## LETTER FROM MNHS DIRECTOR AND CEO

This summer marked a milestone for me, completing my fifth year as director and CEO of the Minnesota Historical Society. The creation of this report is one of my personal highlights each year, because it provides a detailed picture of Minnesotans' commitment to preserving history.

This past year, support was provided for inclusive exhibits that share the stories of several Minnesota communities, for programs that provide hands-on learning opportunities, and for partnerships that are creating a powerful engagement with history across our state. The impact could be felt throughout Minnesota, as grants were awarded in 60 of Minnesota's 87 counties this year.

## FEATURED PROJECTS

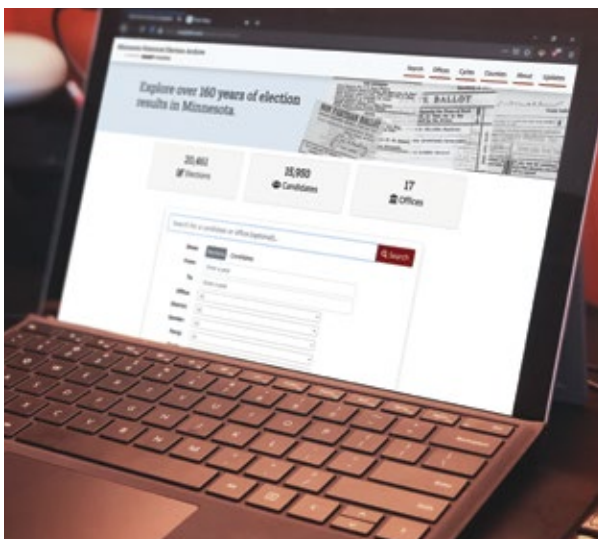
### New Exhibit at Split Rock Lighthouse

The land on which Split Rock Lighthouse stands has been home to people for more than 12,000 years. More recently, the lighthouse has witnessed the growth of shipping and commerce across the Great Lakes, reflecting the need for safer maritime navigation aids. A new long-term exhibit opened in May, featuring stories and traditions from the perspectives of those who have lived there, including the Dakota, Ojibwe, French, and English. At the heart of the exhibit is a full scale replica of the Third Order Fresnel Lens that sits atop the lighthouse. Other notable artifacts include the wheel from the *Madeira*, which sank in 1905, and the hat of Orren Young, Split Rock's first keeper. The exhibit is the site's most extensive programmatic update in a generation.



### Making Minnesota: Free Activity Book

Published by MNHS Press, *Making Minnesota* is a free activity book geared toward children in third through fifth grades, although it is appropriate for students—and adults—of all ages. More than 150,000 copies have been distributed since the book first became available in October 2022. *Making Minnesota* invites readers to learn about the many communities, both human and animal, who call Minnesota home, while educating readers on the unique wildlife habitat, parks, waterways, and cultural institutions within our borders. Young readers can use the book to create their own maps, poems, and drawings of their favorite places to visit. *Making Minnesota* was written and illustrated by longtime educators Patricia Bauer and David Geister.



### Minnesota Historical Candidate Biographical Database

History may be written by the victors, but those who lost also played important roles. The Minnesota Historical Candidate Biographical Database is a new resource that provides searchable biographical data on every candidate and nominee who has run for state and federal office in Minnesota history. The database was created by the University of Minnesota's Smart Politics and built into the Minnesota Historical Election Archive, which contains the returns of more than 20,000 elections across 17 different federal and state offices since 1858. The database will be utilized by county historical societies, general researchers, journalists, and educators across Minnesota.



***Going Out, Coming In: LGBTQ+ Spaces in Downtown Minneapolis at Mill City Museum***

*Going Out, Coming In* brought to life the sights, heart, and energy of Downtown Minneapolis's LGBTQIA+ community spaces from the 1940s to 2000. The exhibit at Mill City Museum featured information and visual elements of various sites where queer Minnesotans organized or created community while addressing the systemic challenges of legal and extralegal discrimination, urban renewal, and the HIV/AIDS crisis. *Going Out, Coming In* stemmed from an ongoing partnership between the Minnesota Historical Society and Twin Cities Pride. It was inspired by the Twin Cities LGBTQ+ History Tours developed by MNHS and TC Pride in 2022.



***Sherlock Holmes: The Exhibition***

Detectives from around the world brought their powers of deductive reasoning to the Minnesota History Center. Thousands of guests from 36 states, 19 countries, and six different continents attended during the exhibit's six-month run from October 2022 to April 2023. The exhibit encouraged detectives to understand not just facts, but how to participate in a process that's very similar to the study of history—gathering and analyzing evidence, thinking critically about the world, evaluating many different perspectives, and figuring out how past events affect the present day.



***Dakota Cultural Collections at the Science Museum of Minnesota: Research, Documentation, and Consultation***

The Science Museum of Minnesota (SMM) furthered an effort to research and promote its Dakota collections and records through the hiring of a Curatorial Fellow with deep knowledge of Dakota material and connections to Dakota communities. Pejuta Haka Red Eagle, formerly collections manager and curator for Hokokata Ti, was hired for this position. In her role, she will collect community input into objects, collections care, and use; produce interpretive pieces about collections objects; and promote SMM's collections through additional outreach and programming opportunities.

# INTRODUCTION

On November 4, 2008, Minnesota voters approved the Clean Water, Land, and Legacy Amendment to preserve and enhance some of the most important elements of our state. This amendment to the Minnesota Constitution, often referred to as the “Legacy Amendment,” created four funds, one of which is the Arts and Cultural Heritage Fund (ACHF).

The Legacy Amendment mandates that a portion of the ACHF be used “to preserve Minnesota’s history and cultural heritage” (Minnesota Constitution, Article XI, Sec. 15). Each January, the Minnesota Historical Society (MNHS) is required to submit an annual report to the governor and legislature detailing expenditures it has made from the ACHF.

This report details all ACHF grants awarded, and projects and programs funded, through MNHS, for **Fiscal Year 2023 (FY23)**, the year ending June 30, 2023.

## **ACHF history projects are benefiting Minnesotans statewide by:**

- Preserving our state’s most valuable historical and cultural resources for future generations
- Sharing our state’s stories and treasured resources with ever-growing audiences including students, teachers, scholars, researchers, genealogists, and the general public
- Connecting Minnesotans of all ages to each other and to history—history that is becoming more accessible than ever before

## APPROPRIATIONS

The Arts and Cultural Heritage Fund receives 19.75% of overall Legacy funding. In 2021, the legislature appropriated \$33.085 million from the ACHF to MNHS for the two-year period July 2021-June 2023. That appropriation breaks down to \$15.588 million for fiscal year 2022 and \$17.497 million for fiscal year 2023. The legislature divided the fiscal years 2022 and 2023 appropriations to MNHS into the following six categories:

## HISTORIC RESOURCES ADVISORY COMMITTEE (HRAC)

Legislation specifies that the HRAC, a volunteer citizen advisory panel that guides decisions for the Minnesota Historical and Cultural Heritage Grants Program, has balanced statewide membership and includes representatives of local, county, and statewide historic and cultural organizations and programs.

It further requires that the HRAC shall include, but is not limited to, members representing the interests of historic preservation, local history, archaeology, archival programs, and other cultural programs related to the history of Minnesota.

## ACCOUNTABILITY

The Minnesota Legislature has reiterated the mandate that every project and program supported by the Arts and Cultural Heritage Fund report "actual measurable outcomes, and a plan for measuring and evaluating the results."

MNHS staff and partners are strongly positioned to ensure that ACHF projects and programs use best practices, current scholarship, and when appropriate, incorporate state-of-the-art technology for demonstrating measurable outcomes. During FY23, MNHS continued to evaluate the impact of ACHF projects and programs to ensure that they demonstrate measurable outcomes as well as economic value for citizens. These results will be shared on a website explained below.

## TRANSPARENCY

The Minnesota Historical Society has an obligation to the citizens of Minnesota to ensure that ACHF dollars entrusted to our care are invested in ways that are transparent and will produce the greatest measurable impact on lives, enabling our state to thrive.

To meet this goal, MNHS has assisted in the building of a website that informs the public about all ACHF initiatives funded through MNHS. Minnesota's Legacy, [www.legacy.mn.gov](http://www.legacy.mn.gov), was created by the Legislative Coordinating Commission and contains information on all Legacy-funded projects. Through the end of the biennium, MNHS will continue to post the most current information about history-related ACHF initiatives ensuring transparency and responsible stewardship of the funds.

# ARTS AND CULTURAL HERITAGE FUND HISTORY APPROPRIATIONS LANGUAGE

**Session Law Reference: Laws of Minnesota, 2021 First Special Session, Chapter 1, Article 4, Section 2, Subdivision 4.**

## **Subd. 4. Minnesota Historical Society, FY2022: \$15,588,000. FY2023: \$17,497,000**

**(a)** The amounts in this subdivision are appropriated to the governing board of the Minnesota Historical Society to preserve and enhance access to Minnesota's history and its cultural and historical resources. Grant agreements entered into by the Minnesota Historical Society and other recipients of appropriations in this subdivision must ensure that these funds are used to supplement and not substitute for traditional sources of funding. Funds directly appropriated to the Minnesota Historical Society must be used to supplement and not substitute for traditional sources of funding. Notwithstanding Minnesota Statutes, section 16A.28, for historic preservation projects that improve historic structures, the amounts are available until June 30, 2025. The Minnesota Historical Society or grant recipients of the Minnesota Historical Society using arts and cultural heritage funds under this subdivision must give consideration to Conservation Corps Minnesota and Northern Bedrock Historic Preservation Corps, or an organization carrying out similar work, for projects with the potential to need historic preservation services.

### **(b) Historical Grants and Programs**

#### **(1) Statewide Historic and Cultural Grants**

\$5,982,000 the first year and \$7,000,000 the second year are for statewide historic and cultural grants to local, county, regional, or other historical or cultural organizations or for activities to preserve significant historic and cultural resources. Money must be distributed through a competitive grant process. The Minnesota Historical Society must administer the money using established grant mechanisms, with assistance from the advisory committee created under Laws 2009, chapter 172, article 4, section 2, subdivision 4, paragraph (b), item (ii).

#### **(2) Statewide History Programs**

\$6,213,000 the first year and \$6,990,000 the second year are for historic and cultural programs and purposes related to the heritage of the state. Of this amount, \$213,000 the first year must be used by the Board of Directors of the Minnesota Historical Society to either produce or purchase and distribute a book to engage and educate elementary school students on Minnesota's natural resources, legacy, culture, and history. The book should be made available cost-free to educators and libraries and through state historical society sites to provide to a targeted grade of elementary school students.

#### **(3) History Partnerships**

\$2,450,000 the first year and \$2,550,000 the second year are for history partnerships involving multiple organizations, which may include the Minnesota Historical Society, to preserve and enhance access to Minnesota's history and cultural heritage in all regions of the state.

#### **(4) Statewide Survey of Historical and Archaeological Sites**

\$475,000 the first year and \$525,000 the second year are for one or more contracts to be competitively awarded to conduct statewide surveys or investigations of Minnesota's sites of historical, archaeological, and cultural significance. Results of the surveys or investigations must be published in a searchable form and available to the public cost-free. The Minnesota Historical Society, the Office of the State Archaeologist, the Indian Affairs Council, and the State Historic Preservation Office must each appoint a representative to an oversight board to select contractors and direct the conduct of the surveys or investigations. The oversight board must consult with the Department of Transportation and Department of Natural Resources.

#### **(5) Digital Library**

\$368,000 the first year and \$382,000 the second year are for a digital library project to preserve, digitize, and share Minnesota images, documents, and historical materials. The Minnesota Historical Society must cooperate with the Minitex interlibrary loan system and must jointly share this appropriation for these purposes.

#### **(6) Grants**

(i) \$100,000 the first year is for a grant to the Litchfield Opera House to restore and renovate the historic Litchfield Opera House.

(ii) \$50,000 the second year is for a grant to the city of South St. Paul to relocate the gatehouses in the BridgePoint Business Park that remain from the Armour & Company meatpacking campus.

### **(c) Balance Remaining**

Any unencumbered balance remaining under this subdivision the first year does not cancel but is available the second year.





# REPORT OF MINNESOTA HISTORICAL AND CULTURAL HERITAGE GRANTS



The ACHF-supported Minnesota Historical and Cultural Heritage Grants Program provides a valuable opportunity for nonprofit and educational organizations, government units, and federally recognized tribes across Minnesota to preserve and share the state's history and cultural heritage. The Minnesota Historical Society administers the Minnesota Historical and Cultural Heritage Grants Program and awards grants based on the recommendations of the Historic Resources Advisory Committee.

Through a competitive process, 3256 grants totaling more than \$75 million have been awarded to 924 organizations in every county in Minnesota since the Legacy Amendment was passed in 2008. This year's report reflects 12 months of grants awarded from July 1, 2022 to June 30, 2023. In this time frame, 161 grants totaling more than \$6,026,125 million have been awarded in 60 counties to 140 organizations across Minnesota.

Minnesota Historical and Cultural Heritage Grants are available in two tiers:

- Small or Structured Grants of \$10,000 or less
- Large Grants of more than \$10,000

Ten percent of grants funding is used to administer and ensure the success of the Minnesota Historical and Cultural Heritage Grants Program. The funds allow MNHS to lead statewide grant-writing workshops and webinars, assist applicants with technical information critical to submitting a successful grant application, and support recipients throughout the duration of their project. Funding also supports collection and processing of grant applications and related data, as well as administration of the Historic Resources Advisory Committee's grant review activities.

To assure transparency and measurable outcomes of projects, as well as proper oversight, grants staff members conduct monitoring visits required by the Minnesota Office of Grants Management and, throughout the grant life cycle, monitor the progress of all awarded grants.

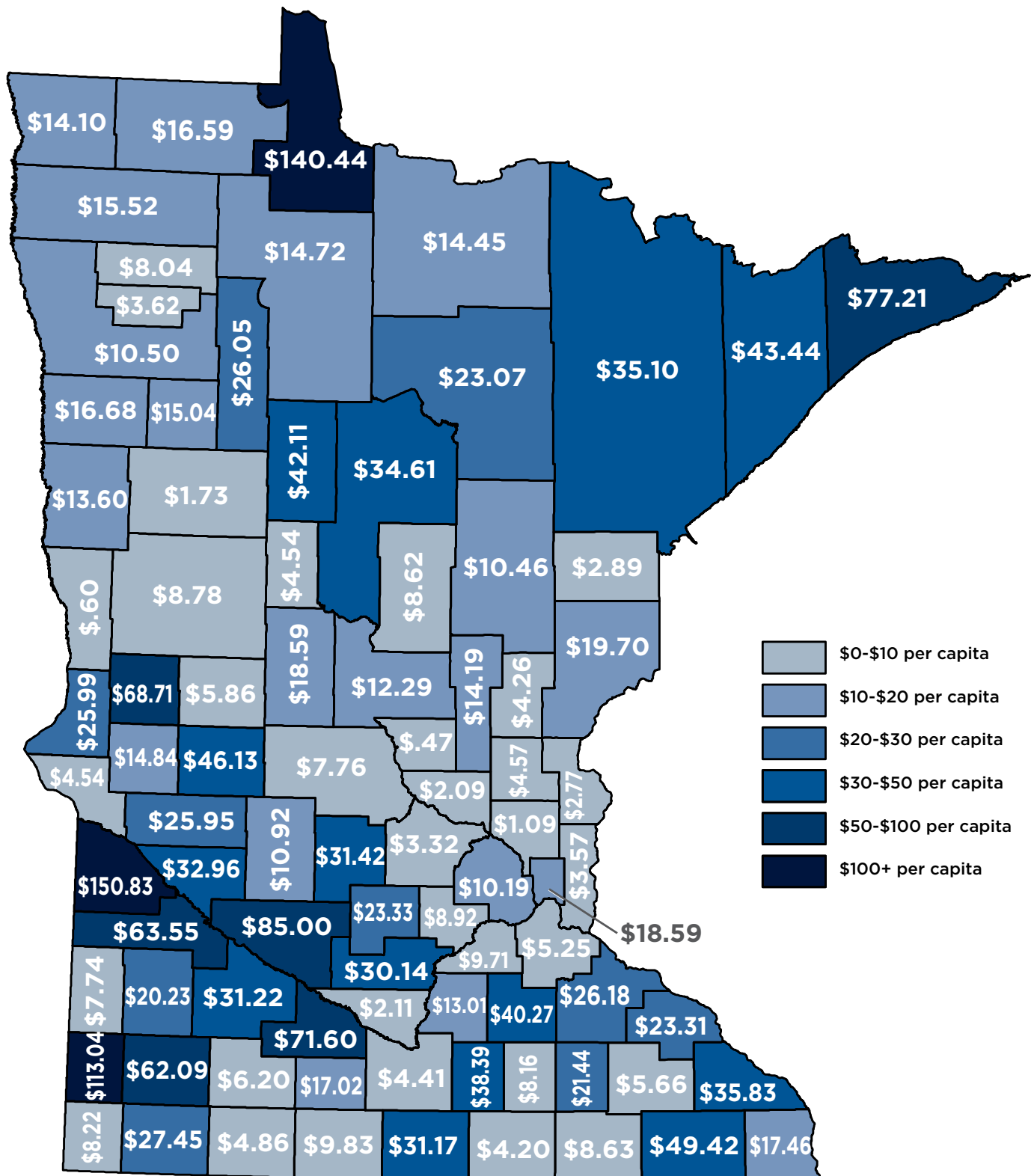

# REPORT OF STATEWIDE HISTORY PROGRAMS



The Minnesota Historical Society has been preserving, sharing, and connecting people with history since 1849. With support from the Legacy Amendment's Arts and Cultural Heritage Fund, the people of Minnesota are investing \$13.203 million this biennium in history programs that will bring the power of history to Minnesotans of all ages in all corners of the state.

This Legacy report presents a look back on how funds were used for Statewide Programs in FY23.

---

**Appropriations Language—Statewide History Programs:** \$6,213,000 the first year and \$6,990,000 the second year are for historic and cultural programs and purposes related to the heritage of the state. Of this amount, \$213,000 the first year must be used by the Board of Directors of the Minnesota Historical Society to either produce or purchase and distribute a book to engage and educate elementary school students on Minnesota's natural resources, legacy, culture, and history. The book should be made available cost-free to educators and libraries and through state historical society sites to provide to a targeted grade of elementary school students.

## ARCHAEOLOGY

### **Archaeological Artifact Inventory of Minnesota River Valley Historic Sites, \$101,538**

This project focuses on creating detailed digital catalog records for archaeological collections that were acquired before digital documentation was possible. This work increases the accessibility and research value of the MNHS archaeological collections. It also brings curation of these collections up to current standards and increases the number of archaeological objects available to view on the MNHS website. The focus of this project is archaeological collections along the Minnesota River Valley, including Fort Ridgely and Upper Sioux Agency Historic Site. This builds upon previous collections work completed for historic sites, such as Historic Fort Snelling. Completing digitization for these collections allows for more convenient access to the collections and eliminates the need for additional storage space required to maintain physical access. Digitization of the artifact collections includes artifact photography, updated artifact descriptions, and narrative writing.

### **Care of Abandoned Archeology Collections, \$62,470**

Over the last ten years, several archaeological collections were abandoned in the state as several universities, institutions, organizations, and private contractor firms closed their doors. In those instances, the archaeological collections were deposited with the Office of the State Archaeologist and/or at the Minnesota Historical Society Archaeology Lab at the Kellogg Center in St. Paul, MN. This project begins addressing those challenges taking inventory of those collections, beginning and completing the processing and curation for those collections excavated from non-federal public lands, identifying ownership of collections from private land, engaging landowners on return of the collections or gift agreements, and planning/implementing as needed. This project works in collaboration with the Office of the State Archaeologist and assists on updating guidance on current curation guidelines and standards (e.g., repository agreements for active projects, abandoned collections), to develop new guidance as needed and engage partner organizations, historical societies, universities, agencies, and the professional community on any revised guidelines and standards.

### **Curator of Archeology, \$44,096**

This project provides funding for the Archaeological Curator position at MNHS to manage archaeological collections and public use materials at the Minnesota History Center and Kellogg Center, provide access to archaeological collections, identify and promote the research needs within the MNHS archaeological collections, engage communities on Minnesota's archaeological heritage through objects and community curation programs, and develop innovative education opportunities and resources for K-12 and university students.

### **Jeffers Petroglyphs Digitization Project, \$88,467**

The Jeffers Petroglyphs digitization project facilitates archaeological site management and conservation to monitor previously identified petroglyphs and cultural features, update archaeological records and collections, and complete new petroglyph and cultural feature inventories on-site at Jeffers Petroglyphs. The digitization project updates and creates new inventories and digital catalog records for Jeffers Petroglyphs and archaeological collections through aerial and terrestrial photogrammetry while increasing accessibility and research value. This will include merging records collected from previous years and geospatially connecting these records together. The project will also complete background research to plan for a non-invasive aerial survey via LiDAR of the MNHS-managed site to document surface features that may be present and contributing significant knowledge to Jeffers Petroglyphs and nearby archaeological sites. This work also supports ongoing efforts to nominate Jeffers Petroglyphs for the National Historic Landmark program and is supported and collaborated by several Tribal Historic Preservation Offices (THPOs), including Lower Sioux Indian Community, Upper Sioux Community, and the Iowa Tribe of Kansas and Nebraska.

### **Archeology Collections Box-Level Inventory Project, \$61,198**

The MNHS archaeological collections contain nearly 2.5 million artifacts from over 4000 collections, and span more than 10,000 years of human occupation in the state. These collections represent more than 150 years of archaeological research in the state of Minnesota and surrounding regions. MNHS continues to add to its archaeological holdings in the present day, primarily in accordance with the Field Archaeology Act and its designation as the repository for archaeological collections recovered from Minnesota public lands. In total, the archaeology collections are stored in approximately 2800 boxes. Several different cataloging systems have been used throughout MNHS's collecting history, which has resulted in the creation of multiple catalog numbers for some of the earlier

collections. In addition, many of the collections were created prior to the implementation of electronic recordkeeping, and any associated documentation exists only as paper records. Some more recent collections were documented with technology that is now obsolete, such as on floppy disks or CDs. The result is a patchwork of associated documentation, including detailed catalogs, not accessible through the CMS. The box-level inventory improves accessibility of archaeological collections to MNHS staff, researchers, and other stakeholder communities through the completion of an inventory, digitization of paper records, enhancement of digital tracking records, and rehousing of artifacts. The completion of a box-level inventory for all archaeology collections housed at MNHS establishes physical and digital control over current location data. The identification and linking of paper and digital catalog data with accession records in the Collections Management System (CMS) will improve recognition of the research potential of archaeological collections.

## EDUCATION AND PROGRAMMING

### **Digital Access Initiative, \$341,667**

In FY23, Legacy funding was used to create and make accessible virtual tours for Alexander Ramsey House, Historic Fort Snelling, and Charles A. Lindbergh House; this project will continue to grow and will eventually extend to the entire Historic Sites network over the coming years. Digital Access funds were also used to extend interpretation into social media, creating an in-depth series about Historic Forestville's 19th century pharmacy on their new Instagram channel. Closing out the fiscal year, Digital Access curated an emerging technology day, where a cross-section of staff from MNHS learned about – and had firsthand experiences with – Virtual Reality, Augmented Reality, and the Metaverse, taking first steps to examine and understand the potential of these emergent technologies.

### **Legacy Field Trip Support Fund, \$52,948**

In FY23, Guest Services used Legacy funds in two ways. Of the \$52,948, salary costs of \$17,072 were used to support staffing in the K-12 Scheduling Office. The remaining \$35,876 was awarded to 106 MN schools to help offset the cost for bussing 8,969 students to 14 MNHS historic sites and museums.

### **Curriculum & Teacher Professional Development, \$110,486**

In FY23, Legacy funds were utilized by the Teacher Education and Curriculum Development Team for staff time and other costs with a focus on teacher training and curricular product development. Teacher professional development offerings include sessions geared towards numerous education constituencies, from elementary teachers to 6th grade Northern Lights curriculum teachers to secondary history and social studies teachers. In addition to staffing costs for workshop development and facilitation, direct program expenses for the annual History Fest teacher workshop were also funded. Funding supported staffing costs for outreach and training sessions provided to college level pre-service teachers in social studies teacher preparation programs and college-level social studies methods instructors and professors. Some project expenses for the Ojibwe Shoulder Bag Activity Kit, a popular supplemental curricular product, were also covered by this fund and help to keep the product updated and relevant as classroom technology changes.

### **Interpreter Training, \$49,606**

Members of the Interpretive Programs team continued to provide the Foundations of Interpretation to new interpreters hired at MNHS. To meet the needs of our changing workforce, an outline was developed for training that will be more customizable by each interpreter and their supervisor to better meet their needs. The goal is to have additional training tracks for specific interpretive needs, including K-12 Audiences.

### **Statewide Program Support, \$200,179**

The Interpretive Programs Team continues to build consistency of programming across the directly managed historic sites. Frameworks were developed for Historic Forestville and Jeffers Petroglyphs. The Framework for the James J. Hill and Ramsey Houses was started and will be completed in FY24. With the Framework development, focus groups with educators were held at the Hill House, Ramsey House, and Jeffers Petroglyphs. IP Team members attended training to support program development at sites and visited the directly managed sites to better understand the space and team members.

**History Center Programs, \$175,068**

These funds were used to support public and interpretive programs at the Minnesota History Center, including a “History’s Mysteries” Library workshop and a Minnesota State band performance. The funds were also used for registration fees for the Native Studies Summer Workshop for Educators for several staff.

**EXHIBITS*****Sherlock Holmes: The Exhibition, \$1,160,272***

These funds were used to bring the traveling exhibit *Sherlock Holmes: The Exhibition* to the Minnesota History Center’s museum. The Minnesota Bureau of Criminal Apprehension and St. Paul based Exhibits Design Group, LLC. contributed to the making of this traveling exhibit that also showcased items from the University of Minnesota’s special collection of Sir Arthur Conan Doyle objects that created an immersive Sherlock Holmes London in St. Paul. The exhibition for visitors of all ages showcased areas of forensic science that enabled Sherlock Holmes to solve crimes and the historical underpinnings of author Sir Arthur Conan Doyle’s rich and vibrant stories.

***Split Rock Lighthouse Exhibit, \$651,691***

These funds supported the development, design, and installation of a new long-term exhibit at Split Rock Lighthouse. This exhibit explores how people have interacted with and tried to control Lake Superior. Highlights of this exhibit include the ship’s wheel from the wreck of the *Madeira*, a full sized replica of the third-order Fresnel lens, media components focused on the power of place, and water which feature Indigenous voices and oral histories, alongside artifacts from lighthouse keepers and their families.

***Going Out, Coming In, \$29,241***

These funds supported the development, design, and installation of a new temporary exhibit, *Going Out, Coming In*, that was displayed at Mill City Museum in The Mill Commons in celebration of Pride Month 2023. This exhibit celebrated the history of LGBTQIA+ communities and community spaces across Minneapolis and tracked the evolution of the Gateway District as a neighborhood from the 1940’s- 2000’s. The exhibit featured information and visual elements of various sites where queer Minnesotans organized or created community while addressing the systemic challenges of legal and extralegal discrimination, urban renewal, and the HIV/AIDS crisis.

***Many Voices, Many Stories, One Place, \$771,783***

These funds were used for the development, design, fabrication, and installation of the exhibit *Many Voices, Many Stories, One Place*. This exhibit, on long-term display at Historic Fort Snelling, presents thousands of years of history, beginning with Bdote, sacred Dakota Homeland as the confluence of the Mississippi and Minnesota Rivers. The exhibit focuses on the history of the military fort that played a pivotal role in the nation’s history and the site’s importance in the formation of Minnesota.

***Then Now Wow, \$44,959***

These funds were used to make technology upgrades to *Then Now Wow* at the Minnesota History Center’s museum.

***Righting a Wrong, \$23,990***

These funds were used to cover staff hours related to the Smithsonian’s National American History Museum traveling exhibit *Righting a Wrong: Japanese Americans and World War II* on display at the Minnesota History Center.

***The Life and Art of Charles M. Schulz, \$284,417***

These funds were used to bring the traveling exhibit *The Life and Art of Charles M. Schulz* to the Minnesota History Center’s museum. This exhibit from the Charles M. Schulz Museum and Research Center in Santa Rosa, California explores Schulz’s personal history and his role as the inspiration and artistic talent behind Peanuts. The exhibit follows his Minnesota roots to his life in California and tracks the development of the characters he created. These funds also allowed the Minnesota Historical Society to present unique objects and photos from MNHS collections that reveal how Schulz’s formative experiences in St. Paul stayed with him for the rest of his life, and to develop interactive activities for visitors of all ages.

***Exhibits Visitor Reflection Space, \$17,283***

These funds were used to create an area for visitors to rest and reflect between three powerful rotating exhibits on display simultaneously. *The Life and Art of Charles M. Schulz*, *Black Citizenship in the Age of Jim Crow*, and *Reframing Our Stories*. Graphics from the Legacy funded project *Art Speaks* were used in this space to present a welcoming and reflective environment.



### **Women of the Big Lake, Misi-zagaa'iganii Ikwewag (Ojibwe), \$5,000**

This exhibit highlights the lives of four women from the Mille Lacs Band that have made significant contributions to their communities as well as American Indian arts and culture in Minnesota. These women have also shared their knowledge and culture with people from all over the world through their roles they played for the Minnesota Historical Society and the Mille Lacs Indian Museum and Trading Post.

### **Exhibit Development, \$60,372**

This funding supported the development and design of a new collections-based exhibit at the Minnesota History Center.

## **FINANCE**

### **Administrative Costs, \$1,173,436**

Administrative costs reflect a portion of the “shared services” costs, such as human resources, payroll, financial accounting, reporting and payment processing, and technology infrastructure, as well as space-related costs for those services. These services are necessary to support the day-to-day operation of Legacy funded programs and partnerships. MNHS works to provide these services at a reasonable cost, and these services are directly related to and necessary for MNHS’s legacy programs.

## **INCLUSION & COMMUNITY ENGAGEMENT**

### **Community Engagement & Programs, \$135,050**

This funding supports relationship building with different communities across Minnesota. In the past year, the Community Engagement team has worked closely with different communities seeking to have their history told more broadly. Most of the Community Programs funding has been used to support the Black Community and Black History. MNHS has worked with the Capri Theater and the MSP Film Society to showcase community films on the first Thursday of each month as well as local film producers to host two film screenings at the Minnesota History Center that focus on Black History in Minnesota. The first film, *Invisible Warriors*, told the story of Black women working in munitions plants in Minnesota during World War II. The second film, *A Great Day in Twin Cities Hip Hop*, highlighted the growth of the Twin Cities Hip Hop scene in the early 1990’s. In addition to the work in the Twin Cities, MNHS has also worked with the Black Community in Greater Minnesota. Some of these funds were used to create a multimedia piece featuring Black leaders in Moorhead. Other funds have been used to start planning gatherings of Black historians in Moorhead and St. Cloud.

In addition to the work with the Black Community, MNHS has been working with the disability community to learn more about that community’s history. Funds have been used to travel the state and meet with different organizations serving that community and to begin planning for gatherings of members of that community to share their stories and history.

### **Veterans Relations, \$101,240**

This funding supported a staff position tasked with assessing and developing sustained engagement between MNHS and the veteran community. This position also provided support for veteran and military-related programs and exhibits and served as a resource for other MNHS staff. Highlights from the past year include:

- Creating a military-focused outreach program for veterans and lifelong learner audiences that included in person and virtual offerings.
- Supporting the World War II Round Table program series at the Minnesota History Center.
- Facilitating tours for active military and veterans groups, military Change of Command ceremonies, promotion and deployment ceremonies, and deployment.
- Attending Military Action Group and United Veterans Legislative Council monthly meetings providing updates on MNHS/Historic Fort Snelling military/ veteran specific programs and events and to determine where Historic Fort Snelling could support other veteran organizations.
- Coordinating donations of military-related program material to MNHS.
- Gathering veteran and military perspectives for the new Historic Fort Snelling visitor center exhibit.
- Building relationships with current active, reserve and national guard military components on the still active Fort Snelling military base.
- Establishing a Veterans Advisory Group to engage the veteran community in Minnesota to advise and assist the Minnesota Historical Society in programming, content, and to create sustained engagement between MNHS and veteran communities in order to provide continual representation of veterans and the military experience that connects to Minnesota history and Minnesota today.

### **College Internship Program \$238,274**

The college internship program provides an opportunity for students to work with experts in the museum field and gain professional experience. MNHS served 40 college interns with a total of 10,172 hours. The interns are from 24 cities throughout the state of Minnesota from Rochester to Moorhead and represent 19 colleges and universities. MNHS made a commitment to pay all interns, providing equity to all. MNHS continues to receive a large number of applications, between 100 to 300 per semester. In addition to operating the college internship program, the staff paid through Legacy funds provided administration, onboarding, seminar planning and implementation, recordkeeping, and payroll functions. Additionally, the Fife and Drum internships were made possible with the Legacy grants, which includes eight internships with 537 hours.

### **Native American Initiatives, \$362,065**

The Native American Initiatives (NAI) team is an advocate for Native communities at MNHS, serving as a bridge between community needs and MNHS resources, engaging with Native communities throughout the state, and ensuring Native voices, stories, and concerns are addressed in MNHS work. The NAI team conducted research, provided content, and created programming and engagement opportunities across the state. Legacy funds supported this work through:

1. The development of a Native teen program – “Reconnecting Our Roots” – a two-session program: one five-week winter after school program and a week-long summer camp. The goals were to provide a learning space for Native American teens where their voices can be heard and they can feel valued, to build community with other students and Minnesota Historical Society staff, and to introduce students to MNHS, museum work and possible careers.
2. The 4th Dakhóta Omníciye was a day-long event to share community knowledge, teachings, and stories. This free event was held at Historic Fort Snelling and included hands-on cultural workshops, artist teachings, film screening, book readings, and presentations from various members of the Dakota communities.
3. Sustained support of the MNHS Indian Advisory Committee (IAC), made up of representatives appointed by the 11 federally recognized tribes in Minnesota and other educators. IAC advises on planning, development and evaluation of MNHS activities and initiatives, including exhibits, publications, public programs, and curatorial policy as they relate to the research, collection, preservation and interpretation of Minnesota and American Indian history in Minnesota. Relationships among IAC members, MNHS, and tribal communities are supported by four annual meetings held in tribal communities around the state.

## **HERITAGE PRESERVATION**

### **MN Historical Markers, \$65,720**

The Minnesota Historical Society has installed more than 200 historical markers across the state since the 1920s but largely stopped the practice in the early 2000s. After completing an in-depth inventory of the markers to better understand their physical location and interpretation, MNHS has been working to pilot an engagement process to understand how various communities interact with these markers and want their history interpreted. The program has also worked to help other individuals and organizations to understand how to care for and consider existing markers.

## **HISTORIC SITES PROGRAMMING**

### **Interpretive Signage Project, \$77,322**

Funding supported the production and staff costs relating to the productions and installation of new and updated outdoor interpretive signage at MNHS historic sites, including the Harkin Store, Lower Sioux Agency, Mille Lacs Indian Museum, and Jeffers Petroglyphs. In addition, FY23 funding supported the work to develop updated outdoor interpretive signage for the following sites: Marine Mill, Sibley House, Folsom House, and Historic Fort Snelling.

### **Draft Animal Programming, \$157,962**

Legacy funding was used to purchase two draft horse teams for the Forest History Center and transport them to the site. Funding was also used to rebuild the cross-load and jammer bobsleds and repair the trolley, purchase a Farmco hay feeder, and cover expenses for veterinary, farrier, fencing, harnesses, hay, employee training, and miscellaneous equine supplies at the Forest History Center. At the Oliver Kelley Farm, legacy funding was used to purchase a people-mover sleigh. At Historic Forestville, legacy funding was used for expenses related to a vendor providing wagon rides for events and for equine workshops.

### **Forest History Center Adventures, \$112,494**

This funding was used to purchase tandem kayaks for the kayak adventure program, expanding offerings for the kayak tour and allowing those looking to paddle in the same boat the opportunity to experience the tour. This funding was also used for a historical program associate to help the Forest History Center present a wider spectrum of forest history, including topics of conservation/preservation, Native perspectives, and immigrant stories.

### **Jeffers Petroglyphs Development, \$66,541**

This funding supports a program assistant position at Jeffers Petroglyphs that uses expert knowledge of site history to develop and deliver new programming and tours to foster wider audience engagement. This includes the development and delivery of the “Sunrise Tour.” This tour provides guests early access to the site during the best lighting in a beyond-the-rope experience engaging discussions about the archaeology of the earliest people in the Midwest and the climatic and environmental conditions they would have faced. This position also evaluated and updated existing content and programming aligning it with the new Interpretive Framework. Along with this, program materials were updated for the Travois, Atlatl, Three Sisters, Bison, and Flint Knapping programs. This funding also supported program delivery safety equipment with the addition of 10 cooling vests. The vests provide up to three hours of cooling to interpreters who deliver programs in the heat of summer.

### **Flour Tower Accessibility, \$27,027**

This project provided open captioning for the Flour Tower multimedia show at Mill City Museum on two flatscreen monitors mounted inside the elevator cab. The work was completed in the spring of 2023 and included electrical work, installing TV monitors and mounts, formatting captions, and programming the system. Spanish-language captions are planned to be added by the end of the calendar year.

### **Bicycle Tours at Historic Fort Snelling, \$8,680**

This funding supported the development of a new program at Historic Fort Snelling to host bicycle tours inside the walls of the historic fort, the bicycle paths around the site, and also the nearby Upper Post where soldiers were stationed during the 20th century and is now part of the new Upper Post Flats community. The tours make numerous stops to share stories from Historic Fort Snelling’s past. Highlights from the past year include: staffing to work with Program Supervisors to develop a bicycle tour route, including historical information on landscape, buildings, and people who have used this land for thousands of years; staffing to deliver the tours to visitors who sign up to take the tours; the purchase of electric bicycles for staff use; and the purchase of safety equipment for staff use, e.g. helmets, reflective vests, first aid kits.

## **LIBRARY, ARCHIVES, AND COLLECTIONS**

### **Digitization of Minnesota’s Newspapers, \$559,847**

The Minnesota Digital Newspaper Hub added 738,389 pages of both current and historic newspapers. With this boost in content, the Hub reached 5,545,548 pages in June 2023. 651,520 current newspaper pages have been digitized with the support of the Legacy Amendment, Arts and Cultural Heritage Fund and with newspapers from publishers throughout Minnesota. 171,782 pages of historic newspapers were digitized from microfilm, and 4706 pages were digitized from print through partnerships with organizations, publishers, and support of donors throughout Minnesota.

Highlights include:

- MNHS received its 7th award from the National Endowment for the Humanities’ National Digital Newspaper Program to digitize Minnesota newspapers for the Library of Congress’s Chronicling America website and for the Minnesota Digital Newspaper Hub. Newspapers selected for this NDNP cycle will be digitized and become available online in late 2023-2024.
- MNHS continues to grow digitization of Minnesota newspapers with the support of many organizations within Minnesota including regional library systems, local libraries and historical societies, and with support from individual donors and Minnesota’s newspaper publishers.
- MNHS’s Minnesota Digital Newspaper Hub hosts and collects Minnesota’s digitized newspapers in one online resource.
- MNHS continues to work with MN Spokesman Recorder publisher Tracey Williams-Dillard to digitize Minneapolis Spokesman and St. Paul Recorder newspapers from the publisher’s archive to fill gaps in the MNHS microfilm, making the newspapers freely accessible in the Minnesota Digital Newspaper Hub.
- In Fall of 2022, the American Indian Learning Resource Center in Duluth donated nine boxes of tribal newspapers, adding to an earlier donation and further growing MNHS’s collection of Native newspapers.

**Digitization of Archival Collections, \$194,671**

In FY23, the Collections Digitization teams digitized 90 collections, representing 70.4 cubic feet of materials. The Library of Congress' transfer of MNHS's *That's the Last Straw* nitrate print, shot in Duluth circa 1938, was delivered in December of 2022. Filmmaker Melton Barker had a fascinating career with his film *Kidnapper's Foil*, but this movie is a rare variation with MNHS's print (now at Library of Congress) being the only known copy in existence. Through last year's award of the CLIR Recordings at Risk, granted to MNHS to digitize videotapes from the Intermedia Arts Video Collection highlighting early documentary/guerilla television in the 1970s and 1980s, all digital files were completed, original materials returned and delivered to MNHS on November 1, 2022.

The Archival collections digitizations team fulfilled 32 scan-on-demand requests in FY23 which encompassed 384 folders and 23 volumes. This includes 61 folders from the Walter Mondale Papers, 30 folders from the Governor Jesse Ventura records, 46 folders from the James J. and Jerome Hill collections, and various State Archives records from courts, counties, and state agencies. Several railroad societies requested materials from the Great Northern, Northern Pacific, and Branch lines collections, including Traffic Department, Advertising, and President's Subject Files.

The entirety of the Hamlin Family Papers, a total of 17 folders that contain mostly letters sent during two brothers' Civil War service, were digitized. The first 11 boxes of the Hennepin County Medical Examiner Reports were digitized and published. The collection dates from 1906 to 1989, and the first 11 boxes are currently on loan for display at the Hennepin County Medical Examiner's office.

In FY23, the Collections Digitization team added a collections digitization assistant, plus three digitization technicians were hired to fill open vacancies and create greater capacity to fulfill all streams of Digitization which include Scan on Demand, Community Digitization, Service, and Mass Digitization.

**Research Scholars, \$23,895**

In FY23, the Gale Family Library Legacy Research Fellowship program supported six fellows and hosted presentations by each individual on their research topic. Topics for FY23 included Minnesota's role in the 1976 presidential election, Athelstan Spilhaus and the Minnesota Experimental City (MXC), the AIDS Crisis in Minnesota History, and a deep dive into one woman's experiences as a patient at Rochester State Hospital in the early 1900s. Results of the research have included MNopedia articles on the topics, book proposals, and presentations to the wider community.

**Library Innovation, \$116,664**

In FY23, the Library Innovation program supported staff work in a variety of areas that helped improve services and access to MNHS materials. Among these areas of work were:

1. Developing new and expanded distance research services to meet researcher needs, including services related to railroad records, historic naturalizations, and state government records. Combined, MNHS fulfilled over 5,800 specific birth/death record orders and over 1,200 more complex research services.
2. Building new indexes that allow access to over 70,000 individuals' county and military records.
3. Expanding options for instruction and group visits, for learners of all ages. This included in-person group research visits for student and community groups, virtual classes and research orientations, and in-person workshops and public programs.
4. Refining and enlarging our systems for data collection—including recording and tracking nearly 14,000 requests to view non-microfilm physical items and over 6000 distance reference questions/interactions. This data is helping us to better serve researchers and supports collection security. This data is also vital to our ongoing processes of developing and sustainably managing ongoing projects and programs.
5. Creating new communication tools and workflows to facilitate and streamline large and small digitization requests, allowing us to deliver over 78,000 digital pages and approximately 1,000 digital media items directly to researchers.

Perhaps the most innovative of the FY23 Library Innovation projects was the development and refinement of the Virtual Viewing program. This program offers staff-assisted live-streaming of archival materials, books, maps, photographs, and other items to researchers, who can then make informed decisions about ordering scans, traveling to visit the library, or seeking information in other record sets or collections. The first 30-minute appointments were scheduled in August 2022, and in January MNHS opened a self-service, online form for researchers to request these appointments directly. This service has been utilized by a wide variety of researchers for many different purposes including:

1. A reporter working with families of 1950s plane crash victims to write a historical investigative article
2. A poet seeking inspiration from a manuscript collection
3. A Civil War historian using a collection of diaries and letters while writing a book about Minnesota soldiers
4. A nonprofit group working with photographs related to the 50th anniversary of the Wounded Knee occupation
5. An art museum tracking the private-owner provenance of pottery pieces in their collections
6. A genealogist searching for a lost family member
7. A graduate student preparing for a short in-person visit related to MN state institutions

### **Oral History Projects, \$37,060**

A renewed commitment to MNHS's Oral History Program positions MNHS as an authority in the field of oral history and advances access to and use of oral histories related to Minnesota history and culture.

The Minnesota Historical Society's Oral History Program is entering an era of revitalization and reimagination, using a steady and thoughtful examination of past methods and practices of the program to rebuild it to align with the strategic imperatives of MNHS and most importantly, reflect the people of Minnesota. This new phase of the Oral History Program includes creating new standards and methods for the program, from research to collecting to activation and engagement; and opening the doors for conversations between interviews, projects, collections, and communities. Using History to Develop a More Informed Citizenry, the MNHS Oral History Program is initiating an in-depth investigation of the existing oral history program to develop a more informed citizenry by transforming access, developing solutions to removing barriers to materials, and identifying effective ways of sharing oral history across communities. Strengthening a Statewide History Community and Collecting Minnesota's Cultural Heritage, The MNHS Oral History Program strengthens the statewide history

community by working collaboratively with MNHS departments and external experts in the field across Minnesota to identify new standards for the program and to expand access and expertise by developing a pilot project that engages a rigorous, core research strategy. As a proof of concept for best practices and future project directions, the pilot will also identify areas of future exploration and new partners for the MNHS Oral History Program. Sustainable Digital Preservation and Access. We are connecting the Oral History Program to departments across MNHS, and the public, by working through an analysis of existing oral history interviews to offer easier access to archives that have not yet been made available. In order to guide Minnesotans to expand access to and knowledge of the fullest breadth of the oral history archive, we are also identifying oral history collections and interviews that are not yet fully accessible and prioritizing access through MNHS discovery systems, digital and analog. This phase of the Oral History Program also includes standardizing workflows and best approaches with Library and Archives cataloging.

### **Minnesota State Capital & Public Art at MNHS, \$58,602**

The newly created program dedicated to documenting, interpreting, and building increased access to and use of the MNHS and associated art collections related to the Minnesota State Capitol and other public spaces under MNHS's purview. The Capitol and MNHS Sites Art Program is committed to ensuring a sustainable future for the use, growth, and stewardship of Capitol and public art collections and has yielded a number of significant achievements in a short amount of time, including the hiring of a talented program specialist in December, 2022.

The renewal of a robust public art program at the Minnesota State Capitol's third floor public gallery that exists for Minnesota artists to tell Minnesota stories. With artists selected by the Capitol Art Exhibit Advisory Committee (CAEAC) and approved by the State Capitol Preservation Commission, six shows featuring a diverse group of Minnesota artists are scheduled through 2025. *Our Austin, Our America* (March 13-October 23, 2023), from photographer William Taufic, featured portrait photography telling the story of immigrants, refugees, and other newcomers who have made their home in Austin, Minnesota. The artist presents the small town as an inspiring example of how communities embrace growing diversity. Upcoming shows include the work of artists Sandra Brick and Fred Amran, Anne Labowitz, John Salgado Maladondo, John Ratzloff, Mary Corwin, and more. MNHS is planning for a comprehensive public art program that includes the History Center and other historic sites throughout the state.



## PUBLICATIONS

### **MNopedia - Digital Encyclopedia of Minnesota History, \$89,505**

MNopedia is MNHS's free online encyclopedia of Minnesota history. MNHS published 26 new MNopedia articles during FY23, covering a wide variety of topics. They ranged from biographies of influential Minnesotans like the artist Bob Brown and social justice activist Irene Gomez-Bethke; to businesses like American Crystal Sugar and Marine Mill, the first commercial sawmill in the state; to items of popular interest, like the Toastmaster toaster and the Beatles concert in Bloomington in 1965. All MNopedia content was curated and fact-checked by the program's editor.

### **Urban Biography Series, \$3,690**

Legacy funds were used to print *Rochester: An Urban Biography* by Virginia Wright-Peterson, the last book in the series of four Urban Biography titles.

### **Making Minnesota Activity Book, \$269,877**

Legacy funding was used to pay for printing of 105,000 copies of the *Making Minnesota* activity book for kids aged seven and up; for distribution of the books; and to pay the author and illustrator honoraria for programming to promote the book, including 27 in-person school visits in all areas of the state; and for marketing the book.

### **Manuscript for *Rewind* Book, \$5,000**

Legacy funding supported the work of David Lawrence Grant, a professional writer, who is co-author of *Rewind*, a memoir by Thea Trice ("T") Williams, a Minneapolis African American leader whose career spans the 1960s to the present.

## RESEARCH & EVALUATION

### **Research, \$302,038**

These funds represent the salaries paid to MNHS Research Department staff to conduct primary and secondary research; write MNopedia articles; engage with television, radio, podcast, and print media on a variety of historical subjects of topical interest; and research and write a new generation of interpretive signs at Harkin Store, Marine Mill, the Lower Sioux Agency, Birch Coulee Battlefield, Folsom House, and other MNHS sites.

### **Program Evaluation, \$117,122**

The Evaluation staff person provided technical assistance and support to staff to evaluate Legacy-funded projects and programs. In addition, Wilder Research consulted on strategy and direction for data informed decision-making and building a culture of evaluation. In the past year, MNHS has conducted evaluative work in the following areas:

- Participated in Measures of Museum Social Impact, a national survey of museum social impact.
- Participated in American Alliance of Museums's Annual Study of Museum Goers, to better understand visitor motivations and provide cutting edge research to the entire museum field.
- Conducted evaluation work for Jeffers Petroglyphs, Historic Forestville, and James J. Hill House Interpretive Framework processes.
- Supported Learning Initiatives Division and K-12 logic model development.
- Supported K-12 Digital team and Lifelong Learning Digital Access team with logic models, surveys for Zoom, and Facebook Live public programs.
- Conducted General Visitor Survey and K-12 Field Trip surveys with revised/updated outcomes.
- Conducted Art Speaks exhibit evaluation at Minnesota History Center Museum.
- Conducted public program surveys as sites re-opened and public programs re-launched after the pandemic.

# REPORT OF HISTORY PARTNERSHIPS



Support from the Legacy Amendment's Arts and Cultural Heritage Fund has resulted in partnerships between the Minnesota Historical Society and more than ten organizations.

It also supports the Heritage Partnership Program, a competitive grant program, that works to build the capacity of two or more independent organizations. In FY23, ten organizations around the state collaborated to preserve and enhance access to Minnesota's history and cultural resources, by supporting the creation and development of sustainable, history-based partnerships.

This Legacy report presents a look back on how funds were used for History Partnerships in FY23.

---

**Appropriations Language-History Partnerships:** \$2,450,000 the first year and \$2,550,000 the second year are for history partnerships involving multiple organizations, which may include the Minnesota Historical Society, to preserve and enhance access to Minnesota's history and cultural heritage in all regions of the state.

## EDUCATION AND PROGRAMMING

### **State Fair Programming, \$51,422**

These funds were used to support the History on a Schtick performances and the State Fair Walking Tour. MNHS worked with the Minnesota State Fair to update and produce the self guided walking tour and the “History-on-a-Schtick” performance. The performance ran twice a day, each day, for the duration of the 2023 State Fair.

### **Minnesota History Day, \$195,433**

Funding for this program supports staff salaries, covering approximately three-and-a-half members of the eight member team. The majority of the other funding went to event costs for competitions, including space and table rentals for eight different Regional contests, printing costs associated with the Regional and State events, outreach visit costs, honorariums for undergraduate mentors providing classroom outreach, the annual National History Day affiliate fee, and program supplies and software to run a successful program for the year.

## FINANCE

### **Administrative Costs, \$168,306**

Administrative costs reflect a portion of the “shared services” costs, such as human resources, payroll, financial accounting, reporting and payment processing, and technology infrastructure, as well as space-related costs for those services. These services are necessary to support the day-to-day operation of Legacy funded programs and partnerships. MNHS works to provide these services at a reasonable cost and these services are directly related to and necessary for MNHS’s legacy programs.

## HERITAGE PRESERVATION

### **Minnesota Main Street Partnership, \$177,097**

The Minnesota Main Streets program is supported by a partnership with Rethos. The program provides support in historic commercial districts in designated Main Street Communities throughout the state using a four-point program of Economic Vitality, Design, Promotion, and Organization. The program provides a network of support to help businesses in historic districts thrive and better their communities. The Buildings on Main Street conference in Winona, just one aspect of support, saw 86 attendees over two days in April 2023.

### **Preservation Education, \$88,399**

These partnership funds support adult education offerings from Rethos. The classes empower Minnesotans to care about historic buildings and teach hands-on skills to preserve the buildings they live and work in. The funds supported 71 education classes with 1173 registrations between July 2021 and June 2023.

### **Building Capacity of History Professionals, \$66,000**

The Minnesota Alliance of Local History Museums (MALHM) and MNHS collaborate to develop the capacity of history professionals across the state to better serve local communities and the 500+ organizations in Minnesota’s history community. Through this partnership, MALHM provides best practices training opportunities, resources, and networking opportunities for local history practitioners. MALHM also works to create a reliable collections management system for local organizations with the capacity for online searching across contributing organizations. The cornerstone of this partnership is the administration of an annual conference that trains paid professionals, volunteers, and board members alike in best practices of history and museum work. The 2023 annual conference was a great success with 196 participants and speakers from across the state. The event was three days with 24 sessions and nearly 20% first-time attendees.

### **Historic Preservation Corps, \$300,000**

This partnership with Northern Bedrock Historic Preservation Corps supports a program to provide preservation skills and training to young adults modeled after the corps programs of the 20th century. Corps members work in multi-day hitches with preservation professionals at older and historic building sites where they learn techniques to repair and preserve the spaces. By the close of the 2022 crew season, the crews had worked on 11 hitches in the state with over 11,000 crew member hours. The 2023 crew season began in May.

### **Disaster Preparedness Training, \$786**

A partnership with the Midwest Art Conservation Center, this project brought cultural organizations from across the state of all sizes and capacity in September 2022 to receive training on disaster preparedness and response. The training was a collaboration between the American Institute for Conservation and the Minnesota Alliance for Heritage Response. The training resulted in closer collaboration between cultural organizations in sharing resources and expertise in the event of natural and manmade disasters that impact cultural collections.

## INCLUSION AND COMMUNITY ENGAGEMENT

### Diversity Outreach, \$344,282

Through community engagement, MNHS builds on relationships and creates partnerships. The funds in this area are used to co-create with communities that MNHS has relationships with. In the Summer of 2023, MNHS opened an exhibit at Mill City Museum called *Going Out, Coming In* that focused on LGBTQIA+ history in Minneapolis. This exhibit came from relationships with Twin Cities Pride and Telling Queer History. MNHS worked with both organizations to ensure that the history of that community was told accurately. From that exhibit, MNHS created a walking tour of downtown Minneapolis to highlight some specific place-based stories in the exhibit and held a series of programs for LGBTQIA+ community members to share their own stories. MNHS began working with similar organizations in Greater Minnesota to expand this work statewide.

In addition, after *The Life and Art of Charles M. Schulz* exhibit opened, MNHS partnered with Saint Paul Central High School, where Schulz went to school, to support an art class in creating their own comics. MNHS partnered with a teaching artist and the administration at Central High School to help students work through the process of creating comics. Students submitted their artwork, and it will be displayed at the Minnesota History Center.

### History of Black Ancestors & Elders, \$28,000

MNHS developed a partnership with the Irreducible Grace Foundation (IGF) in Saint Paul. That organization created a youth center in the Frogtown neighborhood of Saint Paul and wanted to work with youth to research Black leaders. MNHS supported IGF in hiring researchers, and supported those researches as they used MNHS resources to learn about the history of the community. Through that process, IGF learned that the youth center building used to be a school for Native American youth, and MNHS was able to connect IGF with MNHS's Native American Initiatives Department to conduct a small oral history project to capture the story of the Native community as well as Black community in that space.

### Heritage Studies & Public History Graduate Program, \$29,013

Launched in fall 2017, the Heritage Studies and Public History graduate program is a partnership between MNHS and the University of Minnesota. This program takes advantage of the Minnesota Historical Society's extensive resources and expertise to offer unparalleled training in the theory and methods of heritage and public history studies at the graduate level. This two-year program offers a master's degree in one of three cultural heritage tracks: historical archaeology, historic preservation, and public history. Students in the program gain technical knowledge about the field while also learning how to address issues of inclusion and equity within the practice. Through a number of field experiences, students also learn to work collaboratively with community agencies and organizations to enhance historical narratives or develop cultural resources that ensure more equitable practices. Students complete either an externship with another organization or internship with MNHS for a semester. There were seven Heritage Studies internships, totaling 1382 hours.

## HERITAGE PRESERVATION PARTNERSHIP PROGRAM GRANTS

### Black Heritage Trail: Concept Design, \$78,800

*Partners: Dakota County Historical Society (DCHS) and Building Remembrance for Reconciliation (BR4R)*

The Dakota County Historical Society (DCHS) and Building Remembrance for Reconciliation (BR4R) will partner to create a Concept Plan for a Black Heritage Trail. The organizations will have a strengthened partnership as they develop a Concept Plan by combining resources and utilizing a funding opportunity together rather than as competitors. The outcome will result in a better, more extensive project exploring Minnesota's African-American history.

DCHS was founded in South St. Paul in 1939 and has operated to achieve its mission of preserving, interpreting, and promoting the history of Dakota County. BR4R was founded in 2018 as a grassroots organization that volunteers run to use history and the arts to remember, reconcile, and heal, specifically to tell the stories of the Hastings Black community from 1857 - 1954 through art and culture. Together, the partners will further their missions of educating the public by providing a small glimpse into the African-American history of the community. In return, this will strengthen the community even more.

### **Oheyawahe/Pilot Knob Interpretive Program Partnership, \$50,000**

*Partners: City of Mendota Heights, Pilot Knob Preservation Association (PKPA), and Dakota County*

Oheyawahe is comprised of 28 acres of public land located at the convergence of the Minnesota and Mississippi Rivers, known as 'Bdote' and held sacred by the Dakota people. Oheyawahe is within Historic Pilot Knob, a 112-acre site, added to the National Register of Historic Places in 2017. The site is owned and managed by the City of Mendota Heights. The Partnership was formed in 2019 when the City created a Task Force to guide the City Council and City Staff in stewardship of this public resource. The Task Force is comprised of representatives from Dakota County, Acacia Park Cemetery, and the Pilot Knob Preservation Association (PKPA) and is supported by City Staff. The Task Force works on Interpretation and Education, Capital Improvements, and Natural Resources Management. The Heritage Partnership Program (HPP) grant will enhance the capacity for the Partners to work together to provide a long-term Interpretive Program for Oheyawahe that improves public access and safety, educates visitors, and restores the native vegetation of this historical and cultural site.

The Heritage Partnership Program grant will develop a strategic Interpretive Concept Design Plan (ICDP) to provide interpretation materials and inform partners of capital improvements and natural resource management activities that will be necessary to enhance the visitor experience, understanding, and appreciation of this Dakota sacred site's historic and Dakota value. The completed plan will significantly strengthen the vested commitment of the Partners and clarify future roles for the Partners; increase the substantive engagement of Indigenous voices in governmental management; enhance the effectiveness of the Partners, both within their independent organizations and in collaborating on the Interpretive Program for Oheyawahe; and improve access to Oheyawahe by addressing lacking site amenities that would accommodate such visitors such as tour and school groups, and those with disabilities. It is also likely to increase online access with more information utilizing social media and QR codes.

### **Mutual Disaster Assistance Program Development, \$38,526**

*Partners: Minnesota Alliance of Local History Museums (MALHM), Beltrami County Historical Society, Kandiyohi County Historical Society, and the History Center of Olmsted County*

The Minnesota Alliance of Local History Museums (MALHM) Mutual Assistance team developed a project to begin closing a gap in emergency preparedness for local history museums. Emergency

preparedness is the process of planning how to respond to an emergency. For Minnesota's local history community, this is important to protect employees, patrons, buildings, and collections from damage. Many of these institutions are hours away from resources and conservation expertise. They must have up-to-date disaster plans and know how to respond to emergencies. MALHM created the Mutual Assistance Team as a way to coordinate emergency response and provide aid to local history institutions experiencing a disaster.

The partners, Beltrami County Historical Society, Kandiyohi County Historical Society, and the History Center of Olmsted County, are host sites for the Fall 2023 training sessions and provide space rental, access to water, workspace, good lighting, and good ventilation. These sessions will equip 50 museum professionals with the skills and resources to conduct salvage of museum collections damaged by water and direct abbreviated wet salvage workshops in Minnesota's eight regional history groups. In addition, each participant will update or create a disaster plan for their organization, dramatically increasing the percentage of organizations with plans.

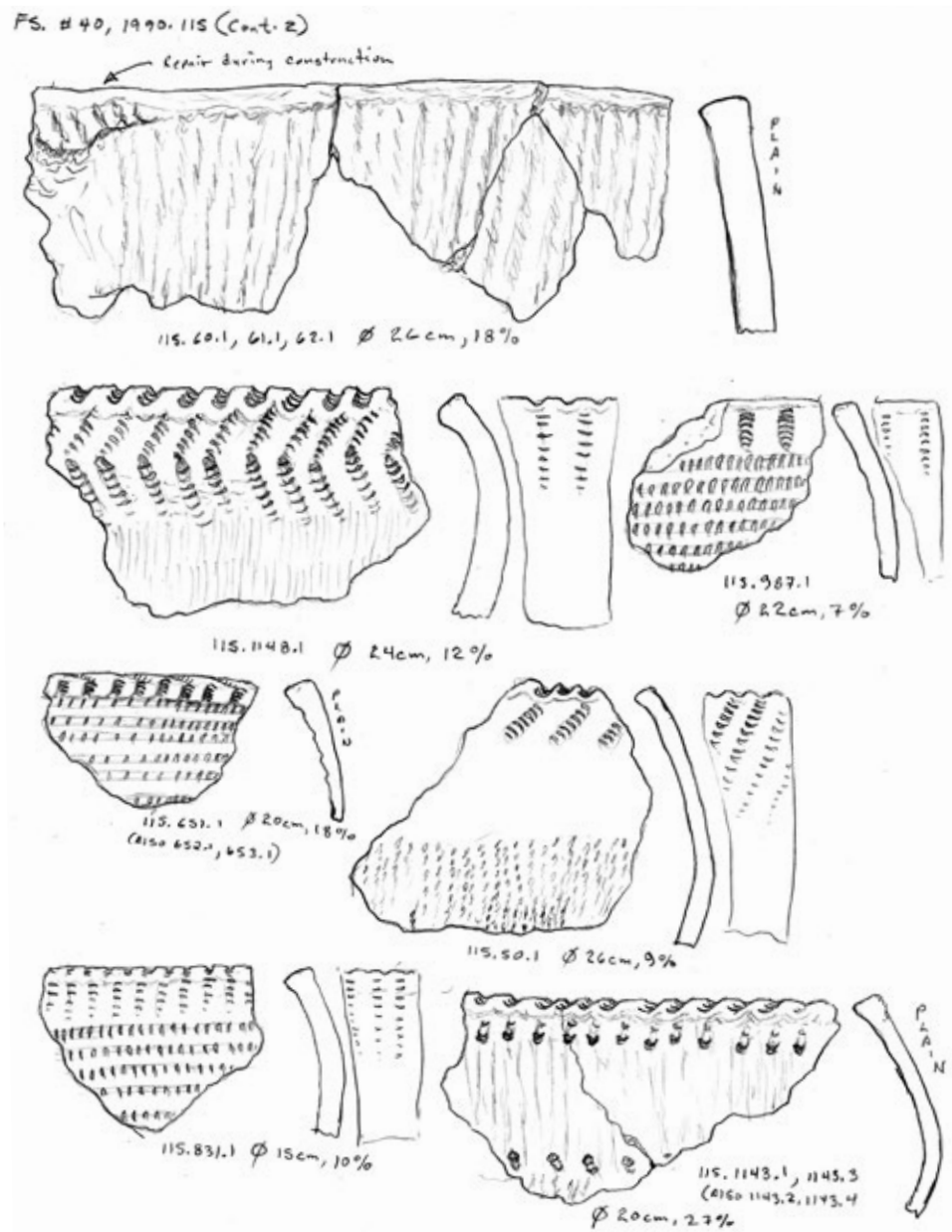
### **Native History Education Initiative, \$70,663**

*Partners: White Bear Lake Area Historical Society and White Bear Lake Area Schools*

The partners, White Bear Lake Area Schools and the White Bear Lake Area Historical Society, have been a part of the Many Faces of the White Bear Lake Area Collaborative since 2018. This collaboration is an informal partnership of 27 different groups. The Many Faces cohort gathered, shared, and highlighted the wide variety of diverse stories and histories in our community with the public. Through this partnership, the Society and School district strengthened their connection and collaboration and began to brainstorm additional ideas for new efforts. The Native History Education Initiative is a new effort to develop a group to identify topics, efforts, resources, and priorities for Native History Education in the White Bear area.

The partners will form a working group to identify experts to help fill in the knowledge gaps. It is essential to realize that the resources that help illustrate the Native stories of our area may not be the typical resources relied upon by educators and historians, such as formal, written records. Instead, historical insights and information may be gleaned from the landscape, oral histories, craft traditions such as canoe making or beading, place names, and other evidence. Specialists will be contacted, vetted, and invited to present their knowledge through written or oral forms. The working group can then develop a Priority Report that establishes a set of recommendations for topics and projects that would advance local Native History Education.

## REPORT OF OTHER STATEWIDE INITIATIVES



In addition to grants, programs, and partnerships, the Minnesota Legislature has appropriated funding from the Legacy Amendment's Arts and Cultural Heritage Fund to support initiatives for history, including the Statewide Survey of Historical and Archaeological Sites, and Minnesota Digital Library. These initiatives support statewide efforts to preserve and share history for future generations.

## STATEWIDE SURVEY OF HISTORICAL AND ARCHAEOLOGICAL SITES



The Statewide Survey of Historical and Archaeological Sites provides opportunities to expand our understanding of these sites statewide. Projects are defined by an oversight board and are conducted through competitive-bid contracts. So far three major topics have been addressed by the survey: identification and protection of sensitive historic and archaeological resources; geographic surveys of poorly known areas of Minnesota; and thematic studies of poorly understood historic contexts.

To date more than 30 projects have been conducted, which have expanded the number of documented historic and archaeological sites in Minnesota, increased our understanding of where such sites are likely to be located, and illuminated cultural traditions, lifeways, and technologies dating to the earliest human occupations of the state.

**Appropriations Language-Statewide Survey of Historical and Archaeological Sites:** \$475,000 the first year and \$525,000 the second year are for one or more contracts to be competitively awarded to conduct statewide surveys or investigations of Minnesota's sites of historical, archaeological, and cultural significance. Results of the surveys or investigations must be published in a searchable form and available to the public cost-free. The Minnesota Historical Society, the Office of the State Archaeologist, the Indian Affairs Council, and the State Historic Preservation Office must each appoint a representative to an oversight board to select contractors and direct the conduct of the surveys or investigations. **An Inventory of Postcontact Native American Cemeteries and Burials in Minnesota**

This project completed an intensive records search to compile a preliminary database of unrecorded historic period Native American cemeteries and burials in Minnesota for the purposes of cemetery and burial management and education for the Minnesota Indian Affairs Council and the Office of the State Archaeologist. The purposes of the project were to summarize what is known about unrecorded historic period Native American cemeteries, to add new information about unrecorded historic period Native American cemeteries to an existing cemeteries database, and to develop a research design for future projects to locate currently uninventoried unrecorded Native American historic period cemeteries.

**Continued Study of Archaeological Radiocarbon Dating**

This project was completed to obtain new radiocarbon dates from selected archaeological sites, to perform statistical analyses of particular sites and complexes, and to continue examining complications with dates on different types of materials from different settings. This work contributes to an ongoing database project and synthesis developed to record the radiocarbon dates from archaeological sites within the state of Minnesota.

## MINNESOTA DIGITAL LIBRARY



The Minnesota Digital Library (MDL) supports the discovery, use, and preservation of the rich historical resources of the state's libraries, archives, museums, historical societies, and other cultural heritage organizations through digitization and online access. In FY23, MDL continued to work with a number of new as well as returning partners, each contributing primary source materials to the MDL's searchable portal at [mndigital.org](https://mndigital.org). This portal offers access to more than 320,000 photos, maps, documents, and more. Just under 200,000 people visited the MDL website with many thousands more engaging through other online channels. Additional MDL work focused on continuing outreach to local history organizations through virtual education and training, while continuing to build digital storytelling efforts such as timelines and maps, to reach wider audiences. MDL grew its Scan for Keeps scanner lending program this year, loaning out kits to 14 organizations statewide as well as adding another large scanner to meet increased demand.

**Appropriations Language—Minnesota Digital Library:** \$368,000 the first year and \$382,000 the second year are for a digital library project to preserve, digitize, and share Minnesota images, documents, and historical materials. The Minnesota Historical Society must cooperate with the Minitex interlibrary loan system and must jointly share this appropriation for these purposes.
